The Bob Walters Property Management System

Licence Agreement

1. True Business Solutions Group Pty. Ltd. A.C.N. 102 703 328 trading as the Bob Walters Team (BWT) has developed THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM, comprising various documents, forms and precedents to be used in connection with property management. BWT warrants that it is entitled to grant this Licence.
2. In consideration of a non refundable fee paid by the Licensee to BWT, BWT grants the Licensee specified in Item 1 of the Schedule a non-exclusive, non-transferable licence to use THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM at the Location specified in Item 2 of the Schedule in accordance with the terms of this Licence.
3. The Licensee acknowledges that this Licence is personal to the Licensee and that the Licensee must not use THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM at any location other than the Location or loan, rent, lease, licence, assign or transfer THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM, or any copy of THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM to any third party.
4. Subject to any and all limiting terms of this Licence, the Licensee is only authorised and entitled to use THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM in the ordinary course of its property management business.
5. The Licensee acknowledges that THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM contains various inventions, know-how, trade secrets, intellectual property, business, corporate, financial and trade information and other information owned and developed by BWT ("Confidential Information"). The Licensee agrees that it must not disclose any Confidential Information to any third party, other than in the ordinary course of its business.
6. The Licensee acknowledges and agrees that BWT retains all copyright and other intellectual property rights in all information contained in THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM. The Licensee must not use THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM in any manner that would derogate from BWT's intellectual property rights in the information contained in THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM and must prevent any unauthorised use, reproduction, distribution or publication of THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM. The Licensee must immediately notify BWT if THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM or any part of it passes into the possession of an unauthorised person. Subject to clause 1 of this Licence and any statutory warranties that cannot lawfully be excluded, the Licensee expressly acknowledges that BWT makes no warranties regarding THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM's compliance or otherwise with Australian State or Federal Legislation and the applicability, accuracy, or completeness of THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM or the compatibility of THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM with the Licensee's existing systems, networks or operating procedures.
8. The Licensee acknowledges and agrees that BWT shall not be liable to the Licensee or any third party for any general, special, indirect or consequential damage and any delay, loss, injury, failure or breakdown that the Licensee or any third party may suffer as a consequence of the Licensee's use of or reliance on THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM or arising as a consequence of any defect, deficiency, omission or inaccuracy of THE BOB WALTERS PROPERTY MANAGEMENT SYSTEM.
